

**PATIENT LEAFLET IN ACCORDANCE
WITH THE PHARMACISTS' REGULATIONS
(PREPARATIONS) – 1986**

This medicine is dispensed without a doctor's prescription

Alcohol 70% Floris Solution

Composition:

Alcohol 70% v/v

Inactive ingredients and allergens in the medicine – see section 6 “Additional information”.

Read the entire leaflet carefully before using the medicine. This leaflet contains concise information about the medicine. If you have any other questions, refer to the doctor or the pharmacist. The medicine is intended for adults, children and adolescents.

Use the medicine according to the instructions in section 3 “How should you use the medicine?” in this leaflet. Consult the pharmacist if you need more information. Refer to the doctor if symptoms of the ailment worsen or do not improve.

1. What is the medicine intended for?

The medicine is intended for disinfection of the skin.
Therapeutic class – antiseptic preparations (disinfectants).

2. Before using the medicine

Do not use this medicine:

- If you are sensitive (allergic) to the active ingredient or to any of the additional components the medicine contains. For a list of inactive ingredients – see section 6 “Additional information”.
- In contact with the eyes, brain, brain membranes, middle ear or outer ear when the eardrum is perforated.
- By injection.
- In the openings of the body (such as: nose, ears).
- When diathermy (a type of a surgical tool) is used after using alcohol – make sure there is no accumulation of alcohol and that the skin and any fabric close to the patient are dry.

Special warnings regarding the use of the medicine

- If the medicine is accidentally given by infusion – blood transfusion may be necessary in order to neutralize hemolysis.

- Do not bring the product near sources of heat or fire.
- Do not light a cigarette or expose yourself to fire before the preparation has completely dried.

Drug interactions:

If you are taking, or have recently taken, other medicines including non-prescription medicines and nutritional supplements, tell the doctor or the pharmacist.

3. How should you use the medicine?

Check with the doctor or pharmacist if you are uncertain about the dosage and how to use the medicine.

Do not exceed the recommended dose.

Method of administration:

Do not swallow! This medicine is intended for external use only.

Avoid contact with the eyes and with mucous membranes. In case of contact wash with plenty of water and refer to a doctor if necessary.

Dosage: the generally accepted dosage is as needed.

Method of use:

Wipe the area intended for disinfection with a cotton wool ball soaked in alcohol whenever necessary. If you took an overdose or if a child swallowed this medicine by mistake, go to the doctor or to a hospital emergency room immediately and take the package of the medicine with you.

Do not take medicines in the dark! Check the label and the dose every time you take a medicine.

Wear glasses if you need them.

If you have any other questions regarding the use of the medicine, consult the doctor or the pharmacist.

4. Side effects:

As with any medicine, using alcohol may cause side effects in some users.

Do not be alarmed when reading the list of side effects. You may not experience any of them.

Side effects with unknown frequency:

- Allergic reactions (for example: inflammation of the skin, itch, redness, eczema, rash, hives, skin irritation, blisters).

If any of these reactions occur, stop using the preparation and seek immediate medical attention.

If a side effect occurs, if one of the side effects worsens, or if you suffer from a side effect not mentioned in this leaflet, consult the doctor.

Reporting side effects

5. How to store the medicine?

- Avoid poisoning! This medicine and any other medicine must be kept in a closed place out of the reach and sight of children and/or infants to avoid poisoning. Do not induce vomiting without an explicit instruction from the doctor.
- Do not use the medicine after the expiry date (exp. Date) appearing on the package. The expiry date refers to the last day of that month.

Storage conditions:

- Store in a cool place, at a temperature below 25°C.
- Close tightly.
- Caution! Flammable substance, keep away from fire.
- After opening for the first time, the medicine can be used up to the expiry date appearing on the package.

6. Additional information:

In addition to the active ingredients the medicine also contains:

Purified water

What does the medicine look like and what are the contents of the package?

Clear, colorless liquid.

Content: 100 ml, 200 ml, 1000 ml.

Not all package sizes may be marketed.
